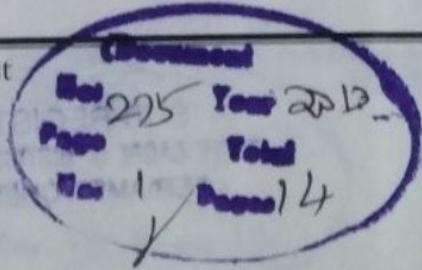

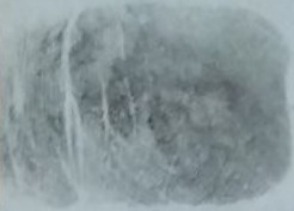

Now this deed of Trust Witnesseth

1. The name of the Trust shall be "N.S.C.& Audikesavalu Guptha Trust"
2. The Office of the Trust shall be at No. 123, N.S.C Bose Road, Sowcarpet, Chennai 600 079.
3. The term Trustees shall mean the Trustees for the time being in force or their successors-in-office as trustees.
4. The Objects of the Trust are:
  - a. To establish, acquire, maintain, run and extend aid, assist and support in establishing, running and maintaining of all kinds of educational institutions including school, arts & Science college, engineering, agriculture and medical college, management & other training institutes and other organization for distant education system.
  - b. To promote chain of educational institutions, grant franchise and render services in the field of education.
  - c. To establish, acquire, run and maintain libraries and reading rooms

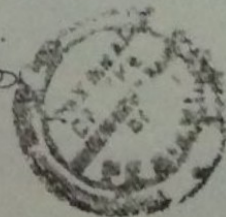

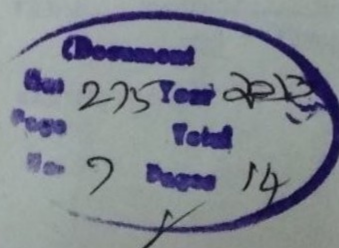




- d. To support/sponsor institute awards for research activities for all educational purposes including in that of field of ancient Indian educational systems
- e. To enable, encourage, support or/and grant aid to promote Legal, Aesthetic, Spiritual and other forms of education
- f. To Provide grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing education, vocational training, skill development etc
- g. To establish endowments for the purpose of encouraging education.
- h. To publish or arrange for the publication of books, journals, periodicals, brochures on the above subjects or towards achieving the above objectives
- i. To hold seminars, conferences, workshops, study circle meetings from time to time
- j. To take monthly or other periodical or lump-sum grants and contributions for the advancement of education to educational institutions
- k. To enable and encourage pupils to take up Sports by promotion of physical education
- l. To develop in children and the youth a sense of discipline, conduct, good education, spirit of self employment and to enable them to secure good employment by running, developing and extending workshops, training centres on Indian educational

systems including study and dissemination of Ethical principles and sports.

m. To establish boarding and lodging houses, hostels, gymnasiums for students

n. In furtherance to the above objects, to raise funds, to purchase or acquire immovable and movable properties including vacant sites and buildings, to enter into lease or rental agreements, to sell or other wise encumber mortgage such property and to construct, demolish or renovate such buildings as occasion warrants

o. To grant donations, contributions towards charitable activities

p. To do all such other things or deeds as may be conducive or necessary for the advancement of above objects.

5. Assets of the Trust:

a. The Founder of the Trust hereby declares that a sum of Rs.10116 /-(Rupees Ten Thousand and One Hundred and Sixteen only) handed over by him to the Trustees has been dedicated for the charitable purposes and objects stated above.

b. The trustees shall stand possessed of the said sum of Rs.10116 /-(Rupees Ten Thousand and One Hundred and Sixteen only) upon Trust and also of any other sums / properties which the Trustees may from time to time acquire or receive by way of donations, contributions, gifts or grants.

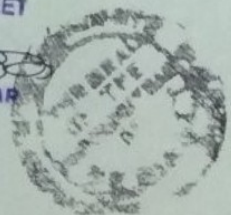

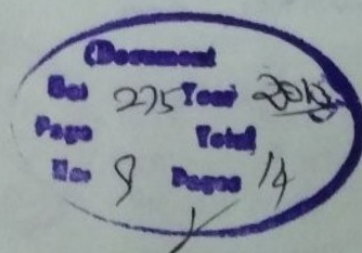




- c. All the Funds and assets of the Trust, the income arising from the investments of the Trust and all assets, collections, claim and rights which by any means may become the property of the trust.
6. The Board of Trustees shall comprise of the Trustees named above who shall hold office for their lifetime from the date of formation of the trust or until they resign therefrom. The Board of Trustees may co-opt further trustees who shall hold such office for a period of 2 years from the date of their appointment and shall be eligible for reappointment. The number of Trustees shall not be less than 2 and not more than 12.
7. Any vacancy arising in the office of the Trustees shall be filled up by the surviving or remaining trustees. And also any person who is a family member of the Founder and who is competent to contract over 18 years of age and is interested in the objects for which the Trust is created shall be eligible to be appointed as a trustee.
8. Powers of the Trustees:
- To receive and keep all Trust Funds and monies by way of gifts, donations, contributions and grants and other assets of the Trust.
  - To purchase, take on lease, provide, erect, maintain, keep, construct and put up buildings, equipments etc., and to dispose of the same. Acquisition / Alienation of immovable properties shall be done with prior approval of the Director of Income tax (Exemptions) Chennai.

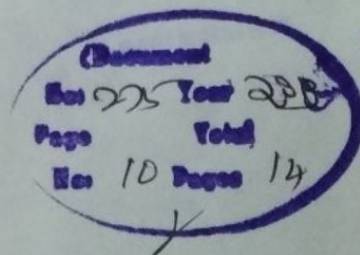





- c. To raise or receive all such loans and advances as they may think proper for the conduct of the Trust.
- d. To have control over the assets of the Trust and to execute, become party to, to sign, acknowledge, perfect and register all deeds, agreements and writing and to give effectual discharge on behalf of and against the Trust.
- e. To invest the funds of the trust in such deposits as per provisions of the Income tax Act, 1961.
- f. To open and operate bank accounts and to close such accounts with any bank.
- g. To institute, conduct, defend, withdraw, compromise or abandon any legal or other proceedings, claims or disputes by or against the Trust or Trustees and for this purpose to sign and verify vakalats, plaints, statements, affidavits and other proceedings before all courts and authorities.
- h. To appoint, suspend, dismiss or discharge any employees for the trust and to fix remuneration, powers and duties for them.
- i. To establish centers in different parts of the country for carrying out the objects of the trust as the activities of the Trust is confined to the Territory of India.
- j. To do such other acts or deeds consistent with powers conferred herein and such other acts authorized by the board of trustees by a resolution.

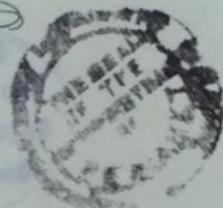

9. The Trustees may delegate by means of a resolution in writing any or all of their powers in any one or more of them for such time and purpose as they may deem fit.

10. The Trustees shall elect from among themselves a President, Secretary and Treasurer and to fix the period for which they shall hold such office. The bank accounts shall be operated jointly by the President and the Treasurer or the Secretary and the Treasurer.

11. The Trustees shall meet at least once in three months and often if necessary. The quorum for the meeting shall be 2. The President shall be the Chairman /Chairperson of the meeting and in his/her absence the trustees present in the meeting shall elect one among them to be the Chairman/Chairperson of the meeting. The vote of majority present at the meeting shall prevail and in case of equal division, the Chairman/Chairperson of the meeting shall have a casting vote.

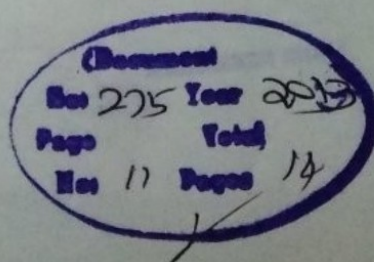
12. A Trustee may at any time resign from the office of trustee by giving one month's notice in writing to the Board of Trustees.

13. The trustees shall be indemnified for any loss incurred or suffered in regard to any act, deed or omission of theirs in the performance or administration of their duties of the trust provided the Trustees have acted in good faith and in the interest of the trust.

14. The Trustees shall maintain true and correct accounts for all trust money and of all the income and expenditure. The accounts of the trust shall be drawn every financial year and the same shall be audited by a Chartered Accountant appointed for the purpose, by the Board of Trustees.

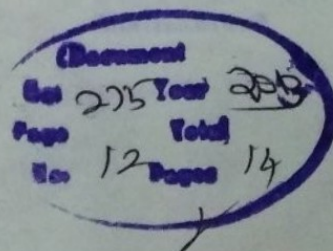
15. The benefit of the Trust shall be open to general public irrespective of caste, creed or religion. The Trust is expressly declared to be a Public Charitable Trust and all the provisions of this deed are to be construed accordingly.

16. The Trust is Absolute and Irrevocable. *NO Immoveable property stands in the name of trust as on date.*

17. No part of the surplus or assets shall be distributed at any time to the Founder or Trustees of the Trust but should be accumulated and utilized for the purposes of the Trust and in accordance with the Income Tax Act of 1961.

18. The terms of the Trust Deed may be amended by the Board of Trustees after obtaining prior approval of Director of Income tax (Exemptions), Chennai.


19. In the event of winding up of the Trust, the net assets of the Trust as at that time shall not be distributed among the Founder or
